Defra Data Services Platform https://environment.data.gov.uk/ Source of environmental data openly available to a wide range of users (also accessible via data.gov.uk).

Scotland's Environment: Data https://www.environment.gov.scot/data/ brings together Scotland's environment to underpin environmental assessments, research and decision making.

Eurostat https://ec.europa.eu/eurostat/web/main/data Provides EU statistics which are also useful to UK data users. General European statistics including economy/finance; population and social conditions; industry, trade, and services; agriculture and fisheries; external trade; transport; environment and energy; science and technology can be accessed through Eurostat.

The UKDS an extensive range of key economic and social data including data on the economy, environment, health, labor market, population, society, travel and tourism and Census information. The UKDS is a national data service.

The catalogue stores metadata to allow users to find information on who is collecting what, where and why. This covers environmental observation programmes and activities.

BODC is the designated marine science data centre for the United Kingdom and part of the National Oceanography Centre (NOC) Its main aims include, providing quality control and archiving of oceanographic data, maintaining an online source of information and improving public access to marine data.

Rothamsted Insect Survey https://insectdatabase.rothamsted.ac.uk/login Rothamsted Insect Survey (RIS) long-term data are unique providing information on aphids, larger moths and many other migrating insects to scientists, growers, conservation organizations, individuals and policy makers. As such, the networks represent the most comprehensive standardized long-term data on insects in the world and have a wide range of fundamental and applied uses.

The Archive is principally funded by the Natural Environment Research Council (NERC) and Science and Technology Facilities Council (STFC).

NERC Earth Observation data Acquisition and Analysis Service (NEODAS)

https://www.neodaas.ac.uk/ Data from the latest satellite passes from a number of sensors such as OLCI, VIIRS and AVHRR are downloaded each day and processed into a range of products using custom processing chains developed by NEODAAS for the scientific community. NEODASS can provide high resolution optical data from Sentinel 2 and Landsat 8, process data collected by digital cameras, LiDAR and NEODASS has NEODAAS has developed a suite of satellite indicators, from key biogeochemical variables, representative of the status of the marine and terrestrial ecosystems. These indicators can be explored to inform regional analysis, add context to short-term trends and specific events, and highlight potential correlations between biogeochemical and physical variables.

UKDMOS is managed and updated by the Marine Environmental Data and Information Network (MEDIN).
